On behalf of the Lebanon County Career and Technology Center (LCCTC), we are pleased to welcome your student to the Law Enforcement & Security program for the 2025–2026 school year!

Students enrolled in the Law Enforcement & Security program are expected to purchase and/or complete the items listed on the attached checklist. All uniform purchases must be made through Major League Screen Printing, which can be contacted at 717-270-9511, or by visiting the LCCTC website at www.lcctc.edu and selecting the "Uniform" link at the top of the homepage.

Please note that in addition to the uniform, every student must come into the program with a SPORTS PHYSICAL dated after May 1st, 2025. Regular annual physicals will not be accepted. Please make sure that you schedule a sports physical when calling. There are a few resources in the community that offer them for free, one being through your home school, but appointments are typically limited. You will have to make arrangements for this to be completed, and if not available for free can be completed at your family doctor, MedExpress, or Urgent Cares in the area. If you student completed one after May 1, 2025 for a school sport you may submit a photocopy of that. All required items must be obtained by the first day of school. Students will not be allowed to participate in any of the physical activities without this document and will result in daily point deductions and progressive discipline. The items below are required for enrollment in this CTC program. Please have all required items purchased and/or completed by the first day of school. Your program has a uniform requirement; you are expected to be in uniform the first day the CTC is in session.

NOTE: Jeans, leggings, shorts, and yoga pants are not allowed in the program. Navy pants should be cargo pants with extra side leg pockets. Anything other than this will be out of uniform and considered out of proper program attire. Students must be present in sneakers every day as physical training is a big part of this program; no other footwear is allowed. All clothing worn daily must contain the badge on the uniform and may not be covered up with personal clothing items (i.e. personal sweatshirts). All long hair must be pulled back out of the eyes and off the collar.
